#### 1. Opening Address by the Chairman, Abdul Kalam Azad

- 1.1 The Chairman welcomed the delegates for the 69th Annual General Assembly (AGA). Before commencing the meeting, Chairman paid a glowing tribute to retired Chairman Dr R Theyvendran, for his immense contribution to the cooperative movement. Chairman informed that he received a letter from his family in March 2020 that for health reasons Dr R Theyvendran has stepped down from all organisations. On behalf of SASCO Ltd Chairman wished him many years of happy retirement and good health. Chairman also informed the during the year Mr Fok Council Member resigned in June 2020 and Mr M.Lukshumayeh Treasurer resigned in October 2020.
- 1.2 Chairman said that this 69<sup>th</sup> General Assembly was held virtually via Zoom webinar because of the COVID-19 induced pandemic environment. Notwithstanding Chairman was glad to report that a total of 29 delegates from 10 affiliates were nominated to attend the AGA. Chairman informed that the Executive Council continued to make good progress to clear remaining outstanding issues and pleased to report that SASCO Ltd Annual Reports from 2016 to 2019 and Audited Financial Statements from 2016 to 2019 were completed and submitted to the Registry. Chairman updated that the Auditors are taking action as appropriate on all remaining business subsidiaries and focus on our core programmes namely SASCO Child Care Centres and SASCO Senior Citizens' Home. Chairman thanked all affiliates and the current Exco members for their continued support and looking forward for the incoming Exco members to forget the past and bring SASCO Ltd to greater heights. Chairman also expressed his sincere thanks and appreciation to the Registrar of Cooperatives and staff for their valuable advice and guidance.








# SASCO Home Organisation Chart 2020
